Case Examples

£20m multi-party claim brought by 26 property owners of flats within a residential development against two insurers in respect of the negligent certification of the construction works and their claim under a Housebuilding warranty provided at the time of construction.

Claim against the sellers and manufacturers of wind turbines sold to a farmer. The claim concerned warranties provided and issues over the service and maintenance of the wind turbine and the sellers obligations.

Solicitor's claim for unpaid legal fees in respect of their retention to conduct three pieces of litigation and a counterclaim brought by the client in claiming professional negligence in the conduct of the retainer and overcharging of fees.

Claim brought against a funeral undertaker in respect of alleged breach of contract on the day of the funeral by reason of a failure on the day to be able to access the church and chapel to hold the funeral service.

Claim for defective works in respect of the construction of a kitchen, family room and conservatory and counterclaim by the contractor for non-payment of fees. (Several similar claims)

Claim by landscape gardener against a commercial entity in respect of unpaid fees arising out contracted and non-contracted landscape gardening works. Issues of sub-contractor works and agency works.

Domestic building claims brought by clients over the construction of additions to domestic homes, e.g. conservatories, kitchens, patios etc (several similar claims).

£2m claim brought to retail eye laser surgery in respect of flooding to the property by reason of the failure of a joint in the plumbing network. The flood resulted in damage to the delicate laser equipment and a business interruption claim.

£250k fire property damage claim brought by a car recycling plant following a fire to its car crushing. The claim was brought against the Defendant service engineers who had recently serviced and maintained the equipment.

Several subrogated fire and flood property damage claims brought by insurers in respect of recovery from third parties of monies paid out to their insured in respect of the first party claim.

£500k claim brought by a jeweller against his insurer in respect of a repudiated insurance claim arising out of two robberies. Issues in respect of the theft, ownership of the insured property and compliance with policy terms.

Claim brought by local authority against farm in respect of flooding which caused damage to the local authority's highway. Damage resulted from refuse from farm blocking culverts which formed part of the area flood defence.

Property development claim – Claim brought by seller of land and purchaser of property to be built on the land, in respect of the value of land purchased and sold and failure to build property as contracted for and defective works in respect of residential domestic home built.

Case in respect of the defective manufacture and installation of metal door on a silo that failed soon after their installation.

Multi-party claim brought leaseholders against freeholders of a residential apartment block and freeholders brought against the company managing the apartment block under a Right to Manage

Claim brought in respect of a family translation business over the alleged wrongful acquisition of the business and the setting up of a rival business in breach of implied restrictive covenants. (Co-mediation).

£2m Construction dispute brought by a contractor in respect of non-payment of verified payments and the termination of the contract by the developer.
