Mediation Style and Approach

Jane believes that mediation provides a unique opportunity for parties to step away from formal and adversarial modes of communication. Involving both lawyers and their clients in planning the mediation is of critical importance to her in creating the right environment to enable them to communicate and negotiate as effectively as possible.

She has been described as having the ability to communicate with individuals regardless of the scale and dynamics of the group and as having a very personal and professional manner. Clients have described her as having a 'natural

Case Examples

Clinical Negligence Cases Mediated

Medical - claim re: care and treatment of a psychiatric patient

Medical - claim for loss and injury due to post-operative infection

Medical - claim for loss of baby at delivery.

Medical - claim relating to trauma and infection following abortion.

Medical - claim involving out-of-hours service and treatment of a cancer patient.

Medical claim regarding failure to emphasise condition of heart patient sentenced to jail.

Medical - claim due to death of diabetic patient following amputation of leg

Medical - claim against GP's re: failure to diagnose and treat spinal tumour and severe pain and disability suffered by the patient

Medical - claim against hospital re: care and of patient with cancer

Medical - claim against GP re: failure to diagnose cancer

Medical - claim against GP re: death of patient following home visit

Medical - claim against hospital re: death of patient following emergency treatment for gastric ulcer

Medical - claim against GP re: diagnosis, care and management of patient with ovarian cancer

Medical - complaint against hospital re: foot damaged by orthopaedic footwear

Medical - complaint against hospital re: death of drug user

Medical - complaint against GP re: treatment of elderly patient

Medical - complaint against hospital trust re: cancer treatment

Medical - complaint re psychotherapeutic treatment

Medical - claim due to abusive member of staff following death of mother from cancer

Medical - complaint against GP re: treatment and referral for back pain and use of language which may prejudice diagnosis and treatment with reference to ongoing personal injuries litigation

Medical - Complaint re: patients referral to consultant and responsibility for deterioration in his condition

Dental - Complaint re: charges for private treatment

Medical - complaint against GP re: failure to issue prescription for drugs to patient not currently resident in UK

Dental – complaint re: standard of treatment and breakdown of dentist/patient relationship

Dental – claim against dentist re: commencement of unnecessary treatment and cost of remedial work carried out by another dentist

Dental – claim against dentist re: delay in treatment for traumatic injury following bike accident

Medical/employment – complaint against hospital trust by member of staff re: MRSA infection

Medical/Employment – major claim relating to senior board member

Further Case Examples

Jane is frequently called upon to mediate complex cases due to her calm demeanour and approach. Some examples include:

Workplace and Disability Discrimination

Workplace conflict between line manager and employee regarding adjustment to working conditions in the light of a newly diagnosed disability.

Personal Injury

Mediation of personal injury case arising from a road traffic accident and leading to disability. Complex issues arising due to pre-existing disability and allegation of fundamental dishonesty.

Sexual Discrimination

Mediation of dispute relating to allegation of discrimination of female employee over male employee in application for partnership and equal pay.

Merger and Acquisition

Mediation arising from conflict between 2 senior executives and including team members in an organisation that was recently the subject of a take over that impacted on culture and governance processes.

Conflict Coaching

Ongoing conflict coaching following a successful mediation between 2 senior executives.

Boardroom Dispute

Mediation arising from a boardroom and shareholder dispute with allegations relating to unauthorised pay increases and holiday allocation and numerous other issues.

Partnership Dispute

Mediation arising from a partnership dispute where the business is to be dissolved and each partner work independently in the future with each starting new businesses.

Team Mediation

Mediation and conflict coaching with a team involving allegations of bullying and discrimination.

Sexual Abuse

Mediation relating to allegations of historic sexual abuse having lifelong impact.
