## Examples of cases mediated

Professional Indemnity

Claim against Engineer and Architect brought by private house owner arising from defects in design and construction.

Supply and Distribution

Dispute between manufacturer of Medical Devices and its appointed distributor pursuant to Supply and Distribution Agreement

Construction Contracts and Professional Appointments

Claims by homeowner arising from major defects resulting in water ingress and damage to property.

Claim for additional fees between consultant Archaeologist and a Local Authority related to major motorway project.
