Overview

Throughout her legal career, she advised UK and international individuals, families, trustees, private banks and commercial parties on trusts, estate planning, taxation, personal assets (including art, jewellery, racehorses, yachts and planes) and family businesses, and was involved in a number of commercial transactions including securitisations and M&A. She is the author or co-author of a number of books on private wealth and trust litigation, and a regular speaker at conferences globally. She is also ranked in Chambers & Partners High Net Worth, 2024.

Arabella additionally specialised in private wealth disputes, including a broad variety of disputes relating to trusts, wills, family business, partnerships/funds, and tax and domicile matters. Arabella's decision to pursue a career in mediation sprang from her experience as an adviser in mediations relating to inheritance (including mental capacity), family business and family trusts ranging in value from a few million to multiple billions.

Mediation Style and Approach

Throughout her legal career, Arabella's work gave her invaluable insight into the reasons why disputes can arise, how personal relationships can impact on legal/commercial disputes, and the advantages of seeking an early resolution between the parties. Her approach to mediation is therefore calm, knowledgeable and empathetic, and she is not afraid (where appropriate) to use her technical understanding and creativity to facilitate discussions. Arabella can



adapt her style to assist parties where family/personal relationships are the key aspect, or where commercial or technical issues are at the heart of the dispute.

Arabella is also interested in pre-emptive mediation (or 'in life' mediation), which uses mediation skills at an earlier stage, when risks or potential difficulties are first identified, allowing relationships to be preserved without litigation.
