Overview

Examples of cases mediated:

Business Disputes including finance disputes:

- Many different shareholder disputes, including minority shareholder prejudice claims and those involving disputes over termination of employment and pension rights.
- Various disputes where business partners have fallen out including those which were properly characterized as joint venture disputes, partnership disputes and those where the precise nature of the legal relationship between the parties was disputed.
- Disputes over loan agreements both between banks and borrowers but also between non-financial institution lenders and borrowers.
- Cases concerning allegations of fraud and unjust enrichment.
- Breach of contract claims, including where one party additionally claims defamation and/or where the contract has been repudiated.
- Claims for proprietary estoppel and/or undue influence against a former business partner including cases where allegations of abuse and /or claims of Modern Slavery are made.
- Claims for breach of director's duties and preference claims made by insolvency practitioners against former directors.
- Claims for breach of contract in contracts for the sale of businesses including claims for fraudulent misrepresentation inducing a party to enter into a contract.

Professional negligence:

- Claims of professional negligence and/or breach of contract against various professionals including solicitors, estate agents, surveyors, financial advisors including counter claims for unpaid fees.
- Claims of professional negligence and breach of directors' duties against former directors by Insolvency practitioners or by purchasers of a business.
